Message from the Rector

Dear People of St. James',

2021 was another remarkable year for us at St. James'.

We entered the year in full COVID-19 shut-down mode, with Zoom worship on Sundays, Zoom Bible Study and Noonday Prayer on Wednesdays, Zoom Vestry meetings... Zoom, Zoom!

We continued to worship on-line through the Feast of the Pentecost, although we began gathering in-person for outdoor Eucharist on Sunday afternoons during the season of Easter. Our prayers made that patch of the church driveway into a holy space, and I loved lifting the consecrated elements up and into the open sky above us.

Since we restarted worship inside our church, we've done our best to maintain protocols to protect one another and to prevent our becoming a place where the virus might spread. We've worn our masks, we've refrained from singing during surges, we've received only the bread of communion, we've moved our coffee-hour outside.

St. James' was blessed not to lose any to the coronavirus during 2021. However, we mourn for the passing of several beloved members and friends, including the Rev. Ruth Walsh, Bill Iber, and Isabel Spann.

Attendance has been strong, but still less than before the pandemic began. Congregational giving has also been strong, but nonetheless our revenue has decreased due to restricted use of the building and changes in our community. We ended 2021 with a deficit, and with anticipated deficits in 2022 and beyond. Therefore the Vestry has been required to consider options such as selling the rectory to reduce our mortgage expense and to create a sustainable budget for the future.

Through all of this, St. James' continues to be a faithful witness to Jesus Christ, worshiping God, supporting one another, and serving our neighbors. The love we share through our church community is our testimony and our invitation: come, taste and see the goodness of the Lord.



Minutes from the January 2021 Annual Meeting

January 17, 2021

Father Charles Brock called the Annual Meeting of the Parish to order at 10:20 a.m., after determining that a quorum of church members was present. He led the parish in opening prayer. The meeting was held virtually via Zoom during the regular Sunday morning worship service.

The minutes of the 2020 Parish Meeting were presented. David Batcheller moved that the minutes be approved as amended. Mike Morgan seconded the motion. The minutes were approved as amended.

Parish Treasurer Mike Morgan presented the Year-End Financial Report for 2020. Mike discussed the actual receipts and expenditures and answered questions concerning his report.

Mary Bramley, Administration & Finance Chair, presented the Budget for 2021. Individual line items were discussed and questions were answered. Fr. Charles thanked Vestry for the budget preparations.

Chris Marbaker, Junior Warden, presented the nominees for Vestry: Chad Duffield and Mary Lowe, and thanked them for their willingness to serve. A motion to elect the nominees by acclamation was made by Andy Wormser. Ben Justesen seconded the motion and the nominees were elected by unanimous vote.

Fr. Charles and Chris Marbaker expressed thanks to Diana Courtney and Mary Jane Van den Berg for their Vestry service and presented them with a token of gratitude.

Diana Courtney, Senior Warden, gave thanks to all for her time on the Vestry and thanked Fr. Charles and the Vestry for all they have done to support her as Sr. Warden this past year.

Discussion was held regarding the proposal from Fairfax County to compensate St. James' for the work to be done (including storm drain easement and tree removal) to accommodate the new bike trail being built on Mt. Vernon Memorial Highway. Mary Bramley moved to accept the proposed payment of \$20,470. offered by Fairfax County. Chad Duffield seconded the motion. Motion approved.

Fr. Charles spoke briefly about the health of the church during this year of the pandemic. He expressed his gratitude for the support of the staff and Vestry during 2020. He reported there is no schedule yet for regathering in person.

Fr. Charles closed the meeting with prayer at 11:26 a.m. and the worship service resumed.

Administration & Finance

2021 was a challenging year for the church financially, as the rectory was empty for nearly half the year, depriving the church of that rental income. The rectory additionally needed significant repair and refurbishing to prepare it for rent again. The Preschool continues to operate under restricted capacity guidelines from the county, significantly reducing it contribution to revenue as well. A bright spot was Fundraising, which met its goal of \$4500. At the end of the year, the church's balance sheet shows a decrease of \$36,287.65, most of which can be attributed to costs associated with the rectory. An Audit was completed and submitted to the Diocese, covering 2019 and 2020... much thanks to all those who assisted with the auditing process: Andy Wormser, Penny Norman, Cheryl Nostrand, and Mike Morgan. The stewardship campaign for 2022 was successful,

including several new pledges. However, overall pledge commitments were significantly down. Since the revenue side of the church budget does not contain many discretionary items, the vestry has recommended that the rectory be sold, with the proceeds used to pay down as much as possible of the current mortgage. The mortgage can then be refinanced with reduced mortgage payments going forward.



Christian Education

Like most other activities in 2021, the adult and children's education had to continue to adapt to changes related to the COVID-19 pandemic.

We continued Wednesday Bible study virtually. This was held a half an hour prior to the Wednesday morning prayer service. Having a finite time to the study has helped focus the discussion time upon the message and getting the most out of the half hour time allotted. The discussions have been lively, and it's been great to have a consistent group of members meeting again on a weekly basis. The average number of folks attending ranges from 6-15. Adult Forum met on Sundays with an average number of 3-4 people each Sunday.

Children's Christian Education faced challenges as well, in that we were still not able to meet in person for our Sunday School program, partially because of pandemic-related reasons, and also because there was a significant absence of children in our congregation to make Sunday School a viable option of our volunteers. Father Charles graciously offered his time, presence, and insight to children following church services, asking them to draw or write about their "Sightings of the Spirit" during the week. The children seemed very happy to participate and talked at length with Father Charles following the services. It was also an excellent opportunity for them to be present during the entire church service, which enhanced their understanding of how our congregation worships.

Thanks to everyone for being so flexible with our Christian Education offerings. We don't know what 2022 has in store for us, but we know that God is control. We will do everything we can to keep the educational offerings that we do have, and hopefully expand them this year. Continued thanks as well to all of those who volunteered their time, efforts, and suggestions this year.

Music

The music program at St. James' aims to provide faithful musical leadership for corporate worship. Hymns and other musical offerings are prayerfully planned to complement the other portions of the liturgy. Regrettably, we have yet to return to in-person rehearsals and in-church leadership due to the continuing COVID-19 pandemic. From January through May, we supported online worship with prerecorded preludes and hymns for the services. For the latter half of the year, in-person worship allowed us to carefully increase musical participation in Sunday liturgies, but still only with music provided from the organ and masked singing by the



congregation. The exception to this was the memorial service for Bill Iber, at which the Ibers' family friend, Anders Lundegard, collaborated in three saxophone and organ duets comprising the prelude.

The Wicks pipe organ is currently in good repair. Having three technician visits per year for tuning and corrective maintenance has been effective and continuation of this policy is recommended. The organ is functioning well, with only minor deficiencies that do not restrict its usefulness to support worship.

I am eager to see the day come that the choir can safely resume rehearsals and participation in Sunday morning services. Because our numbers are reduced, the scope and style of choir participation may need to change correspondingly. We are always happy to have additional voices join us; please let me know if you would be interested, and if there are accommodations to our current Wednesday rehearsal/ Sunday service choir schedule that might allow your participation. No auditions are required and we have the best reserved seats every Sunday morning.

Plant & Property

2020 was a truly challenging year for our plant and property.

Let's start with the Rectory. A storm brought a tree down on the Rectory roof leading to a major amount of work dealing with the insurance company and repair crews. Then, our long time parishioners and Rectory tenants, Ben and Margaret Justesen, gave notice that they were moving away. In all, we put about \$70,000 into the Rectory—replacing the roof, repairing siding and then paint, kitchen appliances and a countertop so we could rent it after Ben and Margaret's departure.

In our own church building, we're seeing increasing signs of aging—from HVAC systems that have components starting to fail (leading to very hot or very cold temperatures in the sanctuary and offices/gallery/ day care), to the roof on Braxton Hall showing its age. We're working to stay on top of issues and address them when they're as inexpensive as possible. We're expecting the protective glass covering on the stained-glass cross to be installed in 2022. We're hoping that at the same time, they company can re-string the flagpole so we can once again fly the U.S. and Episcopal flags.

I'm grateful for everyone who's come out to help with our clean-up days. Those efforts, plus money from the landscaping fund have really helped us improve the grounds at St. James'. We'll have some more work to do as we recover from this month's snowstorm.

Finally, we expect to see construction coming for the Mount Vernon bike path. The bike path will run along the Mount Vernon Memorial Highway side of the St. James' property. We're looking at which of the Stations of the Cross will need to be moved to accommodate the county project.

Fundraising

COVID and distancing requirements have continued to have a major impact on our ability to gather indoors and bring people together, but despite that we surpassed our fundraising goal for 2021, reaching 101.59% of our goal with \$4569.24 raised across two major fundraising efforts, a number of donations, and even points from credit cards. The biggest two fundraisers this year were the annual Yard Sale led by Marghe Bowker which brought in over \$2500, and the Poinsettia Sale led by Mckayle Braden, Mike Morgan, and many other volunteers which raised over \$450. We have high hopes that 2022 will see us return to gathering in person and will add additional opportunities to find creative ways to meet and exceed our fundraising goals. Mission & Outreach

This is the end of my second term on the St. James' Vestry and my last report for this three year term. I have enjoyed working with Father Charles, Jenny, Mike Morgan and all who have served on the vestry during my tenure. Mission and Outreach was challenging—especially during Covid—but working with our St. James' team made it less so. A special thank you goes to Mary Bramley for her support posting information on Facebook and Nextdoor helping me get the word out about St. James' activities.

Our contribution to Episcopal Relief and Development (ERD) in the first quarter of 2021 was a modest \$705 in comparison to past years of more that \$1,000; not meeting in person at church was a difficult fundraising challenge. We typically collect for this very worthy cause during the first quarter of each year; let's raise the bar - our mission of the first quarter for 2022! The things that ERD funds are 1) child nourishment; 2) clean water for families; 3) care for mothers and their babies; 4) and funds to purchase goats and chickens for families, a stable source of food and income.

Our second quarter mission and outreach effort is to support the Rising Hope Mission Church. (RH). We give financial support to RH most of the year, although last year less than we otherwise would have under "normal" circumstances (\$420, part for the hypothermia shelter and part for other). We also are contributing non-perishable food items since returning this summer physically to St. James'. As with ERD, the need is great. (Because we did not meet in person much of the year, I think many of us sent our contributions directly to RH.) RH is our neighborhood mission church; please remember them when deciding how to give either through the church or directly.

Because of Covid restrictions we did not have the "Rise Against Hunger" event, our third quarter mission, as planned for in November. We are saving the \$500 for our November 2022 event.

I am happy to report that our Martin Luther King Food Drive last January was very successful. We collected almost 1200 pounds of food, paper products and non-perishable items for families in need. As I write this report, I am hoping for a similar outcome for 2022's effort coming up next week. Thanks so very much for all your support.

Last February, we were contributors to Olivet Episcopal Church in their effort to provide hygiene bags to Rising Hope's constituents. We provided soap, toothpaste and toothbrushes, socks, and much more for 1,000 hygiene bags. Quite an accomplishment!

What I am most happy about is our contribution to United Communities' Angle Tree In both 2020 and 2021. In 2021, we collected 34 gift cards totaling \$1,040 for needy children in our community. There were enough gift cards collected in our area to add many more children to the list of recipients than originally planned.

Thanks everyone for all your support of our outreach efforts this past three years.

Delegates to Convention

This past November, more than 390 lay and clerical delegates from across the Diocese gathered online for the 227th Annual Convention of the Diocese of Virginia. Due to ongoing COVID-19 concerns, the Convention that was planned to by in Crystal City had to be moved online at the last minute.

The theme of this year's convention "Broken Open", and the Rt. Rev. Susan Goff illuminated our experience of the last year saying, "We recognize how we have been broken open by the power of the Holy Spirit that moves in us ...We are no longer the Church we were before the pandemic. The Church has been changed. Each worship community is changed. We can't go back to the way things were before, because we're already different. Even if we could, we shouldn't go back to when we were comfortable, because God is always calling us to go deeper and wider, to go beyond our comfort zones and into the world that is so in need of God's love."

Some highlights from around the Diocese

Through virtual worship, some congregations are reaching more people.

Two new worship spaces were consecrated, the first new consecrations since 2004.

Bishops have ordained 26 priests and seven deacons since the pandemic began.

The Diocese also called our first Missioner for Racial Justice and Healing, the Rev. Dr. J. Lee Hill, Jr.

Much of our time was spent discussing resolutions that will have great impact on individual churches and the Diocese as a whole. Several resolutions centered around healing- healing our brothers and sisters who have felt racial injustices, healing the Earth, and healing the relationship between churches and the Diocese.

R1 establishes a Virginia Plan for Covenantal Giving through which all congregations will, by the year 2025, pledge 10% of their plate offerings, pledge payments and regular support to the shared ministries of the Diocese.

R2, R3 and R5 establish best practices for digital and hybrid meetings of congregational and diocesan governing bodies including vestries.

R4*a* establishes an Impact Fund for Racial Justice and Healing. This investment fund will be used to prioritize opportunities within the Diocese to support racial justice and healing.

R6 calls on the Diocese, in acknowledgement of a Climate Emergency, to commit to achieving net zero greenhouse gas emissions by 2045.

R9a requests the appointment of an information gathering and discernment team to explore pathways for discernment and formation in Spanish.

R-10a directs the Bishop to create a Reparations Task Force and calls for \$10 million in support of the work of the task force. The objective of these reparation grants and loans is to provide direct benefits to BIPOC communities, people, and institutions, with preference for any which may have been specifically harmed by past unjust actions by the Diocese of Virginia, its institutions, or churches.
